RESEARCH INTERESTS

My research interests include international criminal law, international humanitarian law, human rights, peace and security and public international law.

My doctoral research looks at the use of external jurisprudence by the chambers of the International Criminal Court, reflecting more generally on the growing significance of judicial decisions in public international law. The research provides an original contribution to the field by setting out where the parameters of judicial cross-referencing should lie for the purposes of the ICC and by providing an insight into the emerging practice of judicial cross-referencing at the ICC through empirical analysis of the Court's early jurisprudence.
